STATUTORY RESPONSIBILITIES

The Statutory Responsibilities of the State Fire Prevention Commission may be found in Title 16, Chapter 66 of the Code and are summarized as follows:

- The Commission shall consist of seven persons appointed by the Governor.
- They shall hold regular meetings at least once a month and special meetings may also be called.
- They shall also have the power to promulgate, amend and repeal regulations for the safeguarding of life and property from hazards of fire and explosion.
- Prior to promulgation, they shall hold at least one public hearing on each regulation, amendment or repealer and shall have the power to summon witnesses, documents and administer oaths for the purpose of giving testimony.
- They shall appoint the State Fire Marshal and State Fire School Director. They shall have complete jurisdiction and management over the State Fire School and the Office of State Fire Marshal.
- The Commission shall have power to authorize new fire companies or substations; resolve boundary and other disputes; prohibit cessation of necessary fire protection services.
- The Commission is empowered to enforce its orders in the Court of Chancery.



AGENCY OVERVIEW

The State Fire Prevention Commission is charged with the protection of life and property from fire for the people of Delaware and to oversee the operation of the Delaware State Fire Marshal's Office and the Delaware State Fire School.

MAJOR ACCOMPLISHMENTS DURING FY 2005

- The Fire Prevention Commission is working with the Attorney General on proposed legislation to strengthen the laws concerning EMT-B criminal background checks.
- The Fire Prevention Commission successfully held the Annual Governor's Fire Safety Conference in October 2004.
- The Fire Prevention Commission BLS Medical Director oversaw the Mark I Kit disbursement program.
- The Fire Prevention Commission updated the Incident Review Policy.
- The DFIRS Program is 100% compliant across the state. Although we are satisfied with everyone becoming compliant it remains very important for the fire companies to report on a regular basis for the program to be successful.
- The Fire Prevention Commission signed a Memorandum of Understanding with Delaware Technical Community College in regard to offering an Associate Degree in Emergency Services.
