On behalf of the Delaware State Fire Prevention Commission, I am proud to present our Fiscal Year 2025 Annual Report. This year reflects meaningful progress in strengthening fire prevention, emergency medical oversight, and public safety across our state.

Highlights of FY 2025 include:

- Conducting 12 Commission meetings and multiple hearings to address fire company, EMS, and community concerns.
- Advancing accountability through impartial investigations and compliance reviews.
- Tracking and analyzing 135 firefighter injury reports to guide training and safety initiatives.
- Expanding health and safety programs to reduce risks and promote wellness for firefighters, EMTs, and staff.
- Managing a \$1.4 million budget responsibly, directing resources to personnel, education, and operations.
- Overseeing EMT and ambulance licensing to ensure readiness and quality of care statewide.
- Breaking ground on a new dedicated facility, marking a milestone in the Commission's history and future service capacity.
- Honoring the legacies of Commissioner Kenneth Ryder and Past Chief Bill Betts, whose service and leadership profoundly shaped Delaware's fire community.

### **Mission Statement**

The Delaware Fire Prevention Commission is committed to protecting life and property by overseeing fire and Basic EMS operations, training, and certification statewide. Through public education, code enforcement, professional standards, and emergency response support, we ensure the highest level of safety for all Delawareans.

## **Statutory Responsibilities**

The Statutory Responsibilities of the Delaware Fire Prevention Commission is to promulgate, amend and repeal regulations for the safeguarding of life and property from hazards of fire and explosion. The Statutory responsibilities of the State Fire Prevention Commission may be found in Title 16, Chapter 66 & 67 of the Code and are summarized as follows:

- The Commission shall consist of seven persons appointed by the Governor.
- They shall hold regular meetings at least once a month and special meetings may also be called.
- They shall also have the power to promulgate, amend and repeal regulations for the safeguarding of life and property from hazards of fire and explosion.
- Prior to promulgation, they shall hold at least one public hearing on each regulation, amendment or repeal and shall have the power to summon witnesses, documents and administer oaths for the purpose of giving testimony.
- They shall appoint the State Fire Marshal and State Fire School Director. They shall have complete jurisdiction and management over the State Fire School and the Office of the State Fire Marshal.
- The Commission shall have power to authorize new fire companies or substations; resolve boundary and other disputes; prohibit cessation of necessary fire protection services.
- The Commission is empowered to enforce its orders in the Court of Chancery.

# Division of Professional Standards and Regulations

### **Office of Investigative Services**




All investigative complaints involving patient care, fire companies, or regulations under any 700 sections must be thoroughly investigated without the interference or prior knowledge of any Fire Commissioner. It is essential that these investigations remain independent and free from influence to preserve their integrity. Fire Commissioners may serve as hearing judges when an individual or party formally requests a hearing; however, Commissioners are required to remain impartial throughout the process.


If a commissioner has prior knowledge of the subject matter of an investigation, they must not participate in the corresponding hearing unless it is determined appropriate by the Deputy Attorney General. In such cases, the Commissioner is obligated to consult with the Deputy Attorney General to determine whether recusal is necessary to avoid any appearance of bias or conflict of interest. Commissioners who proceed with hearing responsibilities despite prior knowledge, without proper clearance, risk compromising the fairness and legality of the process.


Maintaining the impartiality of Fire Commissioners and the confidentiality of investigations is critical to ensuring public trust and the lawful execution of oversight responsibilities. Any deviation from this process may result in the invalidation of findings or proceedings and may expose the department to legal and ethical challenges.


Upon the official closure of an investigation, all Fire Commissioners shall be provided with a summary report of the case. This report shall include the nature of the complaint, findings, conclusions, and any actions taken. Providing this information with post-closure ensures transparency and allows Commissioners to remain informed of departmental matters without compromising investigative integrity.














# **Administrative and Compliance Summaries**





# BLS AMBULANCES BY COUNTY



# <u>Delaware State Fire Service Center</u> <u>Health and Safety Team</u>

#### Mission

The mission of the Health and Safety Team is to develop and promote a healthy and safe environment for all employees, customers, students and visitors to our facilities through the involvement of all individuals with regards to education, communication and safe work.

### Team Roles and Responsibilities

The health and safety activities of the team will include, but are not limited to, the following:

- Identify unsafe work practices and conditions by conducting health and safety inspections. Recommend corrective measures.
- Review accident / incident reports. Obtain and analyze available data on past injuries and illnesses and identify trends. Suggest appropriate corrective actions.
- Assist in the development and implementation of effective health and safety awareness programs.
- Encourage feedback from all individuals regarding health and safety related ideas, problems, and solutions.
- Provide support and serve as a resource in the development, implementation, and maintenance of a comprehensive safety, loss prevention and loss control program.
- Assist in the development of written programs or procedures to ensure compliance with OSHA health and safety regulations.
- Serve as an advisory body to management on health and safety issues.

### **Key Responsibilities**


Management (fire school, fire marshal and commission) shall actively promote and support the Health and Safety Team in the following ways:

- Allow the time for team members participation in meetings, tours and assigned responsibilities.
- Allocate the funds/resources necessary to implement health and safety team activities.
- Support team decisions.
- Provide timely feedback to the health and safety team.

Individual Teams shall serve as a resource to the regular division/business group (fire school, fire marshal and commission) on health and safety issues and will provide reports and necessary documentation. Teams may occasionally support other business groups based on needs. Team members should be available when needed to support the FIRE Team by evaluating health and safety information resulting from fire fighter/EMT injuries including training and response activities. It is expected that a minimum of three employees from each business group be assigned to the individual health and safety team. One shall be the team leader.

#### **Bill Betts**




It is with the heaviest of hearts that we announce the passing of Past Chief Bill Betts.
