1. Raymond M. Lyons (“Respondent”) is a resident of Delaware City, Delaware and is certified as an emergency medical technician (“EMT”) in Delaware pursuant to the provisions of 16 *Del. C.* Ch. 67.

3. On November 22, 2025, Respondent was arrested on the following charges: Strangulation, a felony, in violation of 11 Del. C. §607, and Menacing, a misdemeanor, in violation of 11 Del. C. §602.

5. While speaking with Respondent, Respondent advised the police that he put his hands around the victim's neck knowing she could possibly no longer breathe and that he could have possibly punched the couch next to the victim's head.

7. Respondent has violated Regulation 710, Section 18.4.1.7 of the Delaware State

Fire Prevention Regulations in that he has engaged in “unprofessional conduct”.

8. Respondent has violated Regulation 710, Section 18.4.1.9 of the Delaware State Fire Prevention Regulations in that he is charged with an offense as specified in 16 Del. C. §6712(b).

9. Respondent violated Regulation 710, Section 18.4.2.3 because Respondent’s above-described conduct was “dishonorable, unethical, or other conduct likely to deceive, defraud, or harm the public.”

10. Respondent’s above-described conduct shows that Respondent’s continued practice as a licensed EMT presents a clear and immediate danger to the public health, safety or welfare pursuant to Ambulance Service Regulation 710, Section 18.4.7.

11. On November 24, 2025, the felony charge of Strangulation was filed with Court of Common Pleas and a preliminary hearing was scheduled. *See attached*, marked Exhibit A.

12. Pursuant to 16 *Del. C.* § 6712A, upon the receipt by the Commission of a court document charging an ambulance attendant or EMT licensed by the Commission with a felony, the Commission shall issue an order temporarily suspending the certificate holder’s certificate, pending a final hearing on the complaint.

**WHEREFORE**, pursuant to 16 *Del. C.* § 6712, 6712A and Regulation 14.4.6. the State of Delaware respectfully requests that the Commission:

- a. Issue an order temporarily suspending Respondent’s EMT license;
- b. Serve Respondent with a copy of the Complaint and Motion;
- c. Set a time for a hearing on the allegations set forth above;
- d. Find grounds to impose a temporary suspension on Respondent’s certification; and

- e. Impose such disciplinary measures as the Commission deems appropriate.

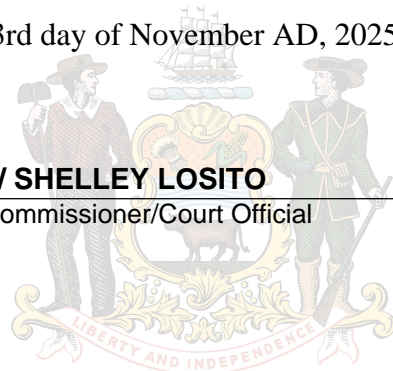

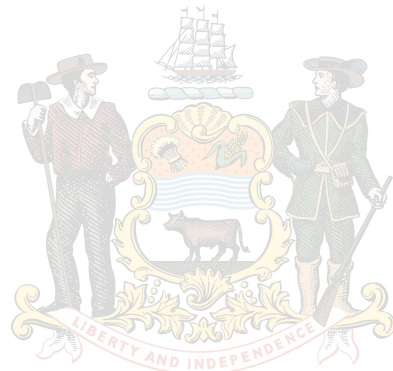

I, your affiant, Officer First Class Cindy Williams #7023, am a sworn police officer for the Delaware City Police Department and is currently assigned to uniform patrol.

On Saturday November 22nd, 2025 at approximately 2200 hours, I responded to [REDACTED] Madison St. Delaware City, New Castle County, Delaware for a reported physical domestic. The victim S [REDACTED] -M [REDACTED] reported to [REDACTED] that her ex-husband the accused Raymond Lyons ([REDACTED]) was physical with her tonight. [REDACTED] reported it to the police because he stated that the accused Raymond Lyons ([REDACTED]) has been recently more violent towards S [REDACTED] [REDACTED] gave me S [REDACTED]'s number to speak with her about incident.

When I contacted S [REDACTED] via cell phone, S [REDACTED] advised me she can only text me right now. S [REDACTED] texted me "My ex-husband Ray, got physical out of no where. Ray came home from work around 1900 hours, seemed fine and normal. Then started to be cuddly and intimate with me and I kept saying leave me alone that I wasn't doing anything with him. So he started talking about how shitbag my daughter's father is and how could I be in love with him. Then he choked me out of no where so I didn't even have time to react. Then he kept lunging at me like he was going to hit me and punched the couch next to my head. And keeps telling me to take the baby and get out of his house."

When I arrived at the residence to speak with the accused Raymond Lyons ([REDACTED]) about the incident he stated they got into a heated argument. I asked the accused Raymond Lyons ([REDACTED]) to explain a little more, and he stated the argument was about their divorce. I asked did anything else happen after that and the accused Raymond Lyons ([REDACTED]) stated he put hands on S [REDACTED]. The accused Raymond Lyons ([REDACTED]) then explained he put both his hands around her neck knowing she could possibly no longer breathe. The accused Raymond Lyons ([REDACTED]) stated he did not know how long he pressed on her neck but he did stop. The accused Raymond Lyons ([REDACTED]) stated that he could of "possibly" punched the couch next to S [REDACTED]'s head.

S [REDACTED] also explained his hands was around her neck and she felt the accused Raymond Lyons ([REDACTED]) thumbs press down on her throat. S [REDACTED] also explained her throat and neck is sore from this incident.

I request an arrest warrant be sworn to for the accused Raymond Lyons ([REDACTED]) for the aforementioned probable cause.

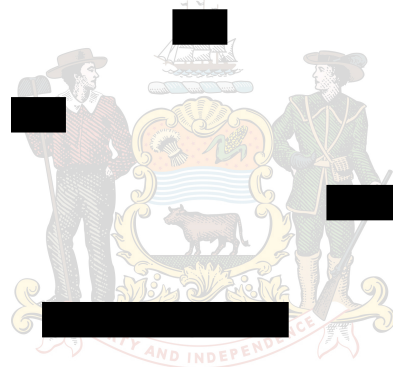

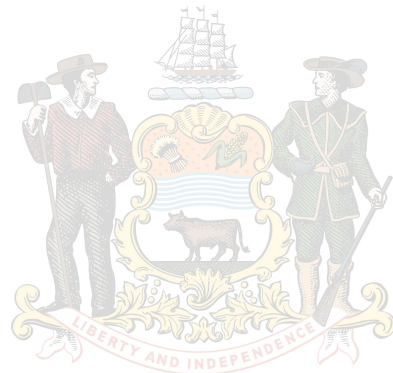
