**COMPLAINT AND REQUEST FOR TEMPORARY SUSPENSION**

1. Daniel L. Moriarty (“Respondent”) is a resident of Seaford, Delaware and is certified as an emergency medical technician (“EMT”) in Delaware pursuant to the provisions of 16 *Del. C.* Ch. 67.

2. Respondent’s EMT certification, I.D. Number 108518 was originally issued on May 21, 2019, and expires on April 30, 2027. His certification is currently active.

3. Respondent returned home on the morning of December 28, 2025, after working approximately 36 hours, leaving work shortly before 6:00am.

4. Upon entering the home, Respondent found his 82-year-old father-in-law making breakfast. While sitting at the table, Respondent suddenly swiped items off the kitchen table and yelled at his father-in-law that he, the father-in-law, does not live there anymore and to get out. Respondent then raised a cocked fist towards his father-in-law, ready to hit his father-in-law. As a result, Respondent’s father-in-law fled to his daughter/Respondent’s wife’s bedroom and woke her up.

5. Respondent’s wife then asked Respondent what was going on. Respondent grabbed his wife by the wrists and squeezed them causing pain and or discomfort. During this altercation, Respondent grabbed his wife by her nightshirt ripping it.

6. Delaware State Police officers arrived at the residence and spoke to Respondent’s

wife and father-in-law. One police officer proceeded to look for Respondent in the residence, yelling for Respondent to come out. Respondent came around a corner with one fist cocked and the other hand trying to grab the police officer's hand that was holding his flashlight.

7. Respondent was then taken into custody. At approximately 1125 hours, a Portable Breath Test was administered to Respondent with a result of .188% BAC.

8. On December 28, 2025, Respondent was arrested on the following charges: two counts of Menacing, a misdemeanor, in violation of 11 *Del. C.* §602; and one count of Offensive Touching, a misdemeanor, in violation of 11 *Del. C.* §601.

9. Respondent has violated Regulation 710, Section 18.4.1.5 in that he has violated or aided or abetted in the violation of any provision of this regulation.

10. Respondent has violated Regulation 710, Section 18.4.1.7 of the Delaware State Fire Prevention Regulations in that he has engaged in "unprofessional conduct".

11. Respondent violated Regulation 710, Section 18.4.2.3 because Respondent's above-described conduct was dishonorable, unethical, or other conduct likely to deceive, defraud, or harm the public.

12. Respondent violated Regulation 710, Section 18.4.2.7 in that he abused or misused alcohol.

13. Respondent's above-described conduct shows that Respondent's continued practice as a licensed EMT presents a clear and immediate danger to the public health, safety or welfare pursuant to Ambulance Service Regulation 710, Section 18.4.7.

**WHEREFORE**, pursuant to 16 *Del. C.* § 6712 and Regulation 14.4.6 and 18.4.7, the State of Delaware respectfully requests that the Commission:

- a. Issue an order temporarily suspending Respondent's EMT license;

- b. Serve Respondent with a copy of the Complaint and Motion;
- c. Set a time for a hearing on the allegations set forth above;
- d. Find grounds to impose a temporary suspension on Respondent's certification; and
- e. Impose such disciplinary measures as the Commission deems appropriate.
