COMPLAINT AND REQUEST FOR TEMPORARY SUSPENSION

1. Nicholas Edward Dykstra (“Respondent”) is a resident of Bethel, Delaware and is certified as an emergency medical technician (“EMT”) in Delaware pursuant to the provisions of 16 *Del. C. Ch. 67*.
2. Respondent’s EMT certification, I.D. Number 0119180 was originally issued on October 23, 2025, and expires on April 30, 2028. His certification is currently active.
3. Respondent and A.K. briefly dated before A.K. ended the relationship.
4. After the breakup, Respondent continued to attempt to contact A.K. causing A.K. to tell him to stop contacting her.
5. Between at least May 2025 and August 29, 2025, Respondent continued contacting and or attempting to contact A.K. despite having been told to stop contacting her.
6. On August 29, 2025, Respondent was arrested on one count of Stalking, a felony, in violation of 11 *Del. C. §1312*, case number 2508016136.
7. As a condition of bail on case number 2508016136, Respondent was ordered to have no direct or indirect contact with A.K. He was ordered to stay 100 or more yards away from A.K. The Order also advises that if Respondent accidentally comes into contact with A.K. in a public place, then it is his duty not to have any contact and to leave the location immediately.
8. On September 20, 2025, Respondent walked past A.K. on the street in Newark. He

then turned around and walked towards A.K. Respondent's friends then pulled Respondent into the Grotto's Pizza. A.K. and her friends also entered Grotto's. Respondent refused to leave Grotto's.

9. On September 20, 2025, a warrant was issued for Respondent's arrest for one count of Felony Noncompliance with Conditions of Recognizance Bond or Conditions in violation of 11 *Del. C.* §2113, case number 2509010547.

10. On December 16, 2025, Respondent was arrested on one count of Noncompliance With Conditions of Recognizance Bond or Conditions, a felony, in violation of 11 *Del. C.* §2113, case number 2509010547.

11. On September 8, 2025, the Delaware State Fire Prevention Commission (“Commission”) received Respondent's application for EMT License.

12. In his application for EMT License, Respondent answered “NO” to the question: “Have you ever been arrested and/or convicted of any National, Federal, State or Local felony and/or misdemeanor including entering a plea or no contest?”. At the time he submitted his application, he had been arrested for the felony charge of Stalking, case number 2508016136.

13. In his application for EMT license, Respondent answered “NO” to the question: “Are there any criminal charges pending against you?” At the time he submitted his application, the felony charge of Stalking, case number 2508016136, was pending.

14. Respondent held an active EMT certification at the time of his December 16, 2025 arrest for one count of Noncompliance With Conditions of Recognizance Bond or Conditions, a felony, in violation of 11 *Del. C.* §2113, case number 2509010547.

15. Respondent failed to self-report his felony arrest for one count of Noncompliance With Conditions of Recognizance Bond or Conditions, a felony, in violation of 11 *Del. C.* §2113,

case number 2509010547, to the Fire Commission as required under Regulation 710, Section 18.8.1.1 and 18.8.1.2.

16. Respondent has violated Regulation 710, Section 18.4.1.7 of the Delaware State Fire Prevention Regulations in that he has engaged in “unprofessional conduct”.

17. Respondent violated Regulation 710, Section 18.4.2.3 because Respondent’s above-described conduct was “dishonorable, unethical, or other conduct likely to deceive, defraud, or harm the public.”

18. Respondent’s above-described conduct shows that Respondent’s continued practice as a licensed EMT presents a clear and immediate danger to the public health, safety or welfare pursuant to Ambulance Service Regulation 710, Section 18.4.7.

19. Respondent violated Regulation 710, Section 18.8.1.1 in that he failed to submit a self-report to the volunteer fire, rescue or ambulance company, or ambulance service provider to which they are a member or employed and to the Commission of any arrests, convictions, charges or adjudications.

20. Respondent violated Regulation 710, Section 18.8.1.2 in that he failed to submit a self-report as required by Section 18.8.1 in writing within ten (10) days of any arrest or release from state custody.

21. On September 18, 2025, the Stalking case, case number 2508016136, was accepted in Superior Court. *See attached*, marked Exhibit A.

22. On December 17, 2025, the Felony Noncompliance with Bond case, case number 2509010547, was filed in the Court of Common Pleas and a preliminary hearing was scheduled for January 6, 2025. *See attached*, marked Exhibit B.

23. Pursuant to 16 Del. C. § 6712A, upon the receipt by the Commission of a court

document charging an ambulance attendant or EMT licensed by the Commission with a felony, the Commission shall issue an order temporarily suspending the certificate holder's certificate, pending a final hearing on the complaint.

WHEREFORE, pursuant to 16 *Del. C.* § 6712, 6712A and Regulation 14.4.6. the State of Delaware respectfully requests that the Commission:

- a. Issue an order temporarily suspending Respondent's EMT license;
- b. Serve Respondent with a copy of the Complaint and Motion;
- c. Set a time for a hearing on the allegations set forth above;
- d. Find grounds to impose a temporary suspension on Respondent's certification; and
- e. Impose such disciplinary measures as the Commission deems appropriate.

1. Your Affiant (I) is Matthew Davis of the Newark Police Department. I have been a sworn Newark Police Officer since July 2025, and am currently assigned to the Patrol Division. I have received police training from the New Castle County Police Academy.

2. The statements contained in this affidavit are based in part upon information provided by victims, witnesses, and other law enforcement officers, along with my experience and background as a Law Enforcement Officer. Since this affidavit is being submitted for the limited purpose of securing an arrest warrant, I have not included each and every fact known concerning this investigation. However, I do not believe I have excluded any fact or circumstance that would tend to defeat the establishment of probable cause. I have set forth only the facts that I believe are necessary to establish probable cause.

3. On 08/28/2025 at 2251 hours I was dispatched to Headquarters in reference to a reported Stalking. I talked with the RP which is [REDACTED]. As I talked with her she reported that [REDACTED] was getting weird messages that the suspect saw her near Grottos. [REDACTED] shortly after connected us to the victim A [REDACTED] K [REDACTED]. After getting in contact with A [REDACTED] via phone call it was difficult to hear her side of the story properly so we asked if we could conduct a interview in person in which she agreed. She stated that she is at [REDACTED] which is in the City of Newark, in New Castle County, in the state of Delaware. Upon arrival to [REDACTED] I came in contact with A [REDACTED] and her roommates and conducted a interview with her inside her residence with Corporal Coughlin.

4. I asked A [REDACTED] to start from the beginning with her story and she says that she studied abroad in New Zealand and met a boy named Nicholas Dykstra [REDACTED]. She states that they were dating about a month and

after figuring out that he had a girlfriend she decided to break off the relationship. She stated that this occurred when they both came back to Delaware at the University of Delaware campus (they were both UD Students at the time). According to A [REDACTED], Nicholas was trying to reach her via sending emails. A [REDACTED] states that on February 26th Nicholas sent her a 2 page PDF Document confessing his love for her. In result of this A [REDACTED] told Nicholas to stop contacting him. It was reported that Nicholas showed up to all her classes even to the ones that he never knew about according to A [REDACTED]. It was also stated that Nicholas did not know anything about the classes that she took beside the Bio-chemistry class that they took together. She stated that this occurred on the UD campus while she was living at [REDACTED] College Avenue in the City of Newark Delaware.

5. A [REDACTED] informed Your Affiant that she was scared of him and his repeated actions. A [REDACTED] informed me that during the last week of Finals Week (May 21st) she went inside class and saw writing on the board that states "I Heart A [REDACTED]" multiple times. He also wrote the message in the front row seats because he knows that she sits in the front area. A [REDACTED] explains that it would have been a calculated move for Nicholas to enter the classroom and draw that picture on the classroom and not get caught. This location was on the University of Delaware campus in Newark Delaware. It was noted that Nicholas was not getting the message and still continuing to try to get her attention. A [REDACTED] stated that there were a few incidents that occurred while they were dating that made her uncomfortable at the time. It should be noted that these occurred prior to them breaking up. One incident involved her and Nicholas speaking together and him randomly stating that he could "beat her up" because he was so much bigger than her. She stated that this was not during an argument and was said nonchalantly. She also stated that there was a time that they were hanging out with friends and he took her in a room to discuss something. A [REDACTED] stated that when Nicholas closed the door at that time she was immediately fearful of his demeanor. She did stated that he never did anything physical to her.

6) It was reported that Nicholas also sent letters to her fathers place of work in [REDACTED] in June to stay in contact with her. Nicholas knew that her father's place of work is [REDACTED]. It was reported that one of Nicholas's letters were random and to just get her attention and to get her back. It should be noted that RP A [REDACTED] states that most of the letters came back to 321 Hillside Rd apartment number 403. The above address is Nicholas's old college residency where he was living at the time. A [REDACTED] told him to stop sending letters/messages to her father's place of work in July and he failed to respect that request because he sent more letters to her father's place of work in August. She stated that he did not know where her father worked and had to look for this information on his own. This all occurred while the victim was still living at [REDACTED] College

7) It was reported that on the evening of 08/29/2025 at approximately 22:51 Nicholas sent her a message saying "I saw you out but I was too scared to say something". A [REDACTED] was scared of receiving this message instantly and decided to tell [REDACTED]. She stated that she was at Grottos in the City of Newark Delaware. A [REDACTED] told Cpl Coughlin and Your Affiant that he lives in Philadelphia but reportedly was in Dewey beach when the message was sent. A [REDACTED] and her friends tracked his location at the time the message was sent via mutual friends. M/cpl Foskey looked up Nicholas on Deljis' Rap sheet and NCIC found a White Toyota Tacoma registered to the address on Nicholas' license. The license plate was [REDACTED]. A Flock search was initiated by M/cpl Foskey and there was a hit near 22 Duke St in Newark around 4:07pm. There was another Flock hit near 501 S College Ave, Newark around 12:41. A Vigilant check was also initiated and there wasn't any hits to access.

8) Cpl Coughlin conducted a Domestic Violence treat assessment where A [REDACTED] screened in. She did not want to speak to the Domestic Violence Hotline but was provided their phone number.

8) Your Affiant believes there is sufficient probable cause for the arrest of Nicholas Dykstra ([REDACTED]) for the charge of Stalking. Your Affiant ask that a warrant be signed.



Your affiant CPL MAIURA can truly state that:

- 1) Your Affiant Corporal Andrew Maiura (I) is a sworn officer of the Newark Police Department assigned to the Uniformed Patrol Division since having graduated from the Delaware State Police Training Academy in 2017.
- 2) The statements contained in this affidavit are based in part upon information provided by the victim, suspect, and other law enforcement officers, along with my experience and background as a Law Enforcement Officer. Since this affidavit is being submitted for the limited purpose of securing a search warrant, I have not included each and every fact known concerning this investigation. However, I do not believe I have excluded any fact or circumstance that would tend to defeat the establishment of probable cause.
- 3) On 09/20/2025, I responded to [REDACTED] Avenue for a report of a potential violation of a no contact order. Upon arrival, I contacted R/p-A [REDACTED] K [REDACTED]
- 4) K [REDACTED] stated that while out on Main Street in the area of the Hyatt Place hotel (94 East Main Street Newark DE 19711), she and her friends observed as her ex-boyfriend Nicholas Dykstra [REDACTED] walked past her heading Westbound. She noted that Dykstra lives approximately 2 hours away and has already graduated from the University of Delaware, with no true reason to be in the area of Newark since being issued a no contact order. After he walked past, K [REDACTED] and her friends walked Westbound on East Main Street in the same direction.
- 5) K [REDACTED] explained that she noticed Dykstra had turned around and was walking toward her in the area of 46 East Main Street. She stated she asked Dykstra something to the effect of "why the hell are you here?" and he replied aloud to his friends with something to the effect of "Legally I'm not allowed to talk to her but you guys can say something". K [REDACTED] said Dykstra's friends pulled Dykstra across the street at the crosswalk and into Grotto pizza. Inside Grotto, K [REDACTED] stated her friend [REDACTED] saw Dykstra and spoke to him.
- 6) Text messages from [REDACTED] to K [REDACTED] reported that Dykstra was in the bar with her and was refusing to leave, although he had an order not to be in the area. Dykstra reportedly told [REDACTED] that he spoke to his lawyer and attempted to show [REDACTED] a voicemail stating the hearing was dropped.
- 7) I found the referenced order and court case listed under DUC#2508016136. This Order states: "You are ordered to have no contact, direct or indirect with A [REDACTED] K [REDACTED], any member of victim's family, the "Alleged Victim", or with the alleged victim's property, residence, place of employment, school, church, or at any other place. No direct or indirect contact means that you are not to be in the physical presence of the alleged victim". It later continues within the order: "You also understand that if you accidentally come in contact with the alleged victim in a public place or other setting, it is your duty not to have any contact and to leave that place immediately.---You are to make no attempts to locate the alleged victim.---You will at all times stay 100 or more yards away from the alleged victim".
- 8) This order was issued to Dykstra during a conditional release following a charge of Stalking in Delaware's criminal code Title 11:1312:00a2.

9) With the use of the City of Newark street surveillance cameras, I was also able to observe that Dykstra walked past K_____ at approximately 2356 hours at the Hyatt Place. It appears that as he passes, he looks over at her before looking away. He was then captured on the East Main Street/Galleria camera in front of the 7-11 at 46 East Main Street talking to several unknown male subjects before turning back to walk Eastbound.
