COMPLAINT AND REQUEST FOR TEMPORARY SUSPENSION

1. Kristina M. Ramirez (“Respondent”) is a resident of Smyrna, Delaware and is certified as an emergency medical technician (“EMT”) in Delaware pursuant to the provisions of 16 *Del. C. Ch. 67*.

2. Respondent’s EMT certification, I.D. Number 0112095 was originally issued on July 13, 2022, and expires on March 31, 2026. Her certification is currently active.

3. Respondent and R.R. were previously romantically involved but had broken up.

4. On January 30, 2026, Respondent was arrested on one count of Offensive Touching, a misdemeanor, in violation of 11 *Del. C. §601*, in criminal case number 2601013263. R.R. is the listed victim in this criminal case. As a condition of bail in case number 2601013263, Respondent was ordered to have no contact with R.R. except for what is necessary for employment. This no contact order remained in place at the time of the February 20, 2026 incident.

5. On February 20, 2026, R.R. was at a Wawa gas pump with R.T. when Respondent pulled up next to them. Respondent did not get gas. No words were exchanged. R.R. and R.T. then left Wawa.

6. After leaving Wawa, both R.R. and R.T. observed Respondent’s vehicle following them.

7. R.R. called Respondent, told her to stop following them, and hung up.

8. R.R. and R.T. made a stop and observed Respondent parked down the street.

9. R.R. and R.T. continued on their way and observed Respondent's car parked behind R.R.'s building.

10. As R.R. and R.T. began to walk to R.R.'s apartment, they observed Respondent standing on the landing in front of R.R.'s door. Respondent positioned herself in a what appeared to be a fighting stance towards R.T. R.R. then got in between Respondent and R.T. and Respondent struck R.R. multiple times.

11. R.T. and R.R. got into R.R.'s apartment, but Respondent forced her way into R.R.'s apartment. Once inside, Respondent attacked R.R. again, striking R.R. multiple times causing injury.

12. During the February 20, 2026 incident, Respondent called R.R. numerous times in violation of the existing criminal no contact order in case number 2601013263.

13. On February 20, 2026, under criminal case number 2602010463, Respondent was arrested on Burglary First Degree, a felony, in violation of 11 *Del. C.* §826; Assault Third Degree, a misdemeanor, in violation of 11 *Del. C.* §611; Harassment, a misdemeanor, in violation of 11 *Del. C.* §1311; Offensive Touching, a misdemeanor, in violation of 11 *Del. C.* §601; Menacing, a misdemeanor, in violation of 11 *Del. C.* §602; and three counts of Breach of Release, a misdemeanor, in violation of 11 *Del. C.* §2113.

14. Respondent has violated Regulation 710, Section 18.4.1.7 of the Delaware State Fire Prevention Regulations in that she has engaged in "unprofessional conduct".

15. Respondent violated Regulation 710, Section 18.4.2.3 because Respondent's above-described conduct was "dishonorable, unethical, or other conduct likely to deceive, defraud, or harm the public."

16. Respondent's above-described conduct shows that Respondent's continued practice as

a licensed EMT presents a clear and immediate danger to the public health, safety or welfare pursuant to Ambulance Service Regulation 710, Section 18.4.7.

17. On February 24, 2026, the Burglary case, case number 2602010463, was accepted in the Court of Common Pleas and is pending a preliminary hearing was scheduled for March 9, 2026. *See attached*, marked Exhibit A.

18. Pursuant to 16 *Del. C.* § 6712A, upon receipt by the Commission of a court document charging an ambulance attendant or EMT licensed by the Commission with a felony, the Commission shall issue an order temporarily suspending the certificate holder's certificate, pending a final hearing on the complaint.

WHEREFORE, pursuant to 16 *Del. C.* § 6712, 6712A and Regulation 18.4.7. the State of Delaware respectfully requests that the Commission:

- a. Issue an order temporarily suspending Respondent's EMT license;
- b. Serve Respondent with a copy of the Complaint and Motion;
- c. Set a time for a hearing on the allegations set forth above;
- d. Find grounds to impose a temporary suspension on Respondent's certification; and
- e. Impose such disciplinary measures as the Commission deems appropriate.
